"Zeolite" is chemically explained as the crystalline aluminosilicate hydrate containing alkaline metal or alkaline earth metal. The general formula is shown as $\text{MeO} \cdot \text{Al}_2\text{O}_3 \cdot m\text{SiO}_2 \cdot n\text{H}_2\text{O}$ (Me: metal ion). "Synthetic zeolite" is obtained by heating to dehydrate from this crystalline "Zeolite".
