### Higher reliability in concentration value to the conventional products.

When the conventional product was measured with CRM amino acid mixture standard solutions, the following dissociations could be shown.

**[Conventional Product]** Type AN-2 (Code No. 011-14463), Type B (Code No. 012-08643), Type H (Code No. 019-08393) By using CRM amino acid mixture standard solutions, such deviations can be eliminated and makes it possible to perform highly reliable analysis.
